APPROVAL OF MINUTES: Motion to accept the May 21, 2009 minutes was made by Justin Addington, seconded by Mack Edwards all voting AYE; none voting NAY.

SPECIAL PRESENTATIONS: Mayor Eileen Deckard opened the floor for public presentation.

Joe Alessandrini handed out a piece of paper with several questions for the council in efforts to save time. The questions are to follow up from previous meetings. Legal Affairs Attorney Mike Carrico advised of a letter he has received from council member Donald Stokes advising of his resignation effective today due to health issues. Mike Carrico requested a motion to allow him to petition the court on behalf of the town to get the council vacancy added to the November ballot. He discussed the grant received by the Scott County Telephone Coop. The town had previously offered the letter of support. The grant was fully funded, and the Telephone Coop was awarded 1.5 million for High Speed internet the project is set to start within the new couple of months.

Motion to accept the resignation was made by Mack Edwards, seconded by Justin Addington all voting AEY; none voting NAY.

Motion to have Mr. Carrico to petition the court to declare the vacancy and get the notice for the special election for a council member on the ballot for the election in November was made by Mack Edwards, seconded by Justin Addington all voting AEY; none voting NAY.

Mayors Report Mayor Eileen Deckard updated on the railroad issues. The railroad does not plan to spray the weeds along the railway. Follow up and see if VDOT or the Railroad, would be willing to reimburse the town for the expense of the mowing.

Ordinances Rhonda Neeley has met with Rebecca Crockett at LENOWISCO efforts to obtain a planning grant.


CLOSED SESSION: None
