## Street Committee Report. Jeff Flanary and Wendell Tipton

No new information to report. The Snow Plowing Crew is on call as of 7 pm tonight for the forecasted snow event.

#### Maintenance Committee Report: Eileen Deckard and Frank Tittle

A metal culvert pipe located near 192 Wilmeth Street has rusted out and has caused a hole in the street that requires attention. The new pipes are made of heavy-duty plastic to avoid these rust outs. Frank Tittle will get an estimate for its repair.

The PSA hired a paving company to finish the repairs at each water line upgrade site, but they are not satisfied with the quality of the work performed. Mike Dishman contacted the Town office to see what company we use for road repairs. He stated that he will contact someone to finish the road repairs correctly.

#### Police Department Report:

Chief Donald Harding, III reported to the Council there have been several arrests made already this year including one by Officer Justin Miller on February 2<sup>nd</sup> of a person with over 30 outstanding drug related warrants.

A date has not yet been set for the new Police Department ribbon cutting. It will be set soon and invitations sent out.

The Weber City Police Department is the recipient of a grant to purchase License Plate Reader cameras in town to assist in recognizing BOLO orders in our town.

## **Brian Mullins**

Mr. Mullins began by thanking the WCPD for their recent assistance in some trouble he experienced at this warehouse business in town. Second, he is requesting the Town's support for the request to VDOT and Scott County EDA to extend Baltic Drive to connect to Frank B. Smith Drive. This road extension will assist in the heavy tractor trailer traffic to the warehouses. He has reached out to VDOT, Scott County EDA, and Lenowisco regarding this road project and each entity is in agreement that the road is necessary and beneficial. They just need a Resolution from the Town Council stating that the Town of Weber City is also in agreement with the request. Both Baltic and Frank B Smith Drives are VDOT maintained roads.

## **Just for Fun Party Rentals**

Rob Ferguson, owner of Just for Fun Party Rentals presented his business to the Town Council, informing them of the services it offered for future Town events and also to request to be kept in mind for any commercial locations available in town to open an indoor play facility for family entertainment. He also asked for information on obtaining

any grant or financial help to assist in funding. The Council suggested he contact John Kilgore of the Scott County Economic Development office to see what small business assistance is available. The Council was excited at the prospect of such a business for Weber City. We have been looking for businesses to invest in our area that will benefit families.

# Statement from Suzanne Kerney Quillen Regarding Street Repair

Vice Mayor, Wendell Tipton, read aloud a statement from resident, Suzanne Kerney Quillen, regarding road repairs required by Scott County PSA:

- "I planned to ask the council to continue to request that the PSA:
- (1) complete the waterline repairs started around July 2024,
- (2) repair all road and driveway damage on Winfield, Roland, Locust, and Church Streets
- (3) repair all grade and personal property damage,
- (4) ensure all repairs correct the now-existing standing water issues and excessive runoff issues caused by the road and grade damage."

In response to this, Town Attorney, Mike Carrico, wrote a Resolution from the Council requesting that the Scott County PSA address the road repair issues to VDOT standards. A motion was made by <u>Teresa Tilson</u>, seconded by <u>Zackary Salyer</u> to send that Resolution and a letter to the PSA Executive Director, Mike Dishman in unanimous agreement of Suzanne Kerney Quillen's request.
